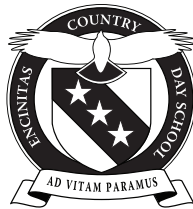

Students attending a single week of an ECDS summer camp will be issued one shirt and one hat on their first day of camp. Any student pre-paying for two or more weeks of camp in a given summer will receive a second camp shirt. Extra shirts and hats are available for \$12 each.
