6. Sunscreen Use and Authorization

I understand that I am to apply sunscreen to my child before dropping him/her off to attend an ECDS Summer Campz program.

I also understand that it is my option to authorize ECDS staff to apply sunscreen, that I provide, to my child as needed throughout the day when he/she is attending an ECDS summer program. If I have authorized its use, it is my responsibility to supply ECDS Campz personnel with an unexpired bottle/tube of sunscreen, labeled with my child's first and last name.

7. Dress Code Policy

Students attending a single week of an ECDS summer Campz will be issued one shirt and one hat on their first day of Campz. Any student pre-paying for two or more weeks of Campz in a given summer will receive a second Campz shirt. Extra shirts and hats are sometimes available for \$16 each. For safety and other reasons, students must wear Campz shirts and athletic closed-toe shoes.

8. Splash Days & Beach Days

On a splash or beach day, students can either bring their bathing suits to change into, or they can wear them under their clothes. Closed-toe shoes are still required during the camp day, but sandals may be worn when walking to and from the water slide or to and from the beach. Remember, bring a towel and water bottle for your camper.

9. Absence Policy

Tuition fees for Campz are paid in consideration for a place in ECDS summer programs. No refunds or credits accrue to students who are absent during the weeks that they are enrolled in ECDS Campz.

10. Refund Policy

No refunds will be considered beyond 72 hours after the RRA and payment are submitted. A full refund, of paid but unearned fees, will be provided if a camp is cancelled by ECDS for any reason.

11. Hold Harmless Release

I hereby assume all risks of injury or illness for my child that may occur while participating in any ECDS Summer Campz activity, or using facilities or equipment owned or rented by ECDS. I will in no way hold ECDS, its agents, contractors, employees, or its successors and assigns liable for lost or damaged belongings or injury that my child may sustain while involved in a summer program based at ECDS.

12. Financial Responsibility

I assume financial responsibility for my child and agree to meet all financial obligations when they are due.

13. Understandings & Agreements

I understand that if, for any reason, it is found to be in the best interest of ECDS, ECDS reserves the right to nullify an accepted Registration & Release Agreement in a Summer Campz program. If ECDS nullifies an RRA, all advance fees paid but not earned will be refunded and any balance due will be waived.
